**DESCRIPTION:**

DIGITAL PRINTING IS NOT ACCEPTABLE.

Printing: Label prints with type matter, signature, and barcode in black ink only. Eight (8) identical labels per sheet (2 across and 4 down). NOTE: Final product must be compatible with laser printer.

Construction: Coat the entire back of the label for each sheet with a permanent type adhesive. Kiss cut label paper vertically 4-1/4" from left /right edges and horizontally in 3 places every 2-3/4" to form a sheet of 8 labels (2 across and 4 down). Die cut each individual label with round corners. Die-cut label paper only, do not penetrate backing sheet, and remove waste.

One (1) PDF file for production.

GPO Form 917 (Certificate of Selection).

GPO Form 2678 (Departmental random copies-blue label).

Contractor can download the "Labeling and Marking Specifications" form (GPO Form 905, R. 7-15) from [gpo.gov](http://gpo.gov), fill in appropriate blanks, and attach to shipping containers.

Prior to image processing, the contractor is responsible for performing a basic check (preflight) of the furnished publishing files to assure accurate output of the required reproduction image. Any errors, media damage or data corruption that might interfere with proper file imaging must be reported to the contract administrator in sufficient time to comply with the shipping schedule.

In addition, the contractor is responsible for creating or altering any necessary trapping, setting proper screen angles and screen frequency, and defining file output selection for the imaging device being utilized. All furnished files must be imaged as necessary to meet assigned quality level.
