QUANTITY: 14 Total equal to 9 sets of Concept 1, and 5 sets of concept 2 PLUS (1) complete set of prior to production sample (MUST be approved prior to production).

One (1) Backdrop Banners 84 x 96" (7 x 8') - With display, and carrying case
Two (2) Retractable Banner Stands With carrying cases & (2) different Roll Up Banners - 36 x 84".
One (1) iPad brochure holder/display: approx. 14 x 73" with carrying case, and wrapped with printed fabric.
Three (3) Retractable Top Banner Displays With carrying cases & (3) Different Roll Up Banners - 15 x 24".

To be considered for award, bidders must send a specification sheet, photo, or web link that clearly shows how the product offered (Backdrop Display, Retractable Banner Display, Top Display, and iPad Brochure Holder/Display) complies with the features below. Government to approve/disapprove within 2 workdays from receipt.

QUALITY LEVEL: 3 Quality Assurance Through Attributes (GPO PUB 310.1, effective May 1979 (Rev. 9-19)) applies.

DESCRIPTION:

All the requirements of these specifications apply equally to all Items unless otherwise indicated herein.

DIGITAL PRINTING REQUIRED (Dye Sublimation Printing is Acceptable).

The product will be produced via inkjet wide-format digital printing provided that Quality Level III standards are maintained. Final output must be wet ink, pigment-based. Dry ink/toner printing is not acceptable. Output must be at a minimum resolution of 720 x 720 dpi plus a RIP that provides an option for high quality color matching such as Device Links Technology and/or ICC Profiles.

PRINTING: All Items print face only in full bleed (heavy coverage) with type matter, logos, illustrations, screen tints, and solids in 4-color process. Must use UV ink.

Note: All Items must have suitable finish (pockets for poles, hemming, hook, and loop fasteners, double side tape ...etc.), and include all necessary hardware for setup, and a case that will protect all components. All retractable banners, and top banners must be installed in their displays.

IPad Brochure Holder/Display must be wrapped with printed fabric, and have a protecting case.

WARRANTY: Contract Clause 15, "Warranty", of GPO Contract Terms (GPO Publication 310.2, effective December 1, 1987 (Rev. 01-18)) is amended for the solicitation to the effect that the warranty period is **EXTENDED** from 120 days to five calendar years from the date the check is tendered as final payment. All other provisions remain the same.

MATERIAL FURNISHED: Contractor to pickup at GPO. One (1) Thumb Drive with PDF files. Contractor to extend bleed as necessary. Contractor is responsible for any size adjustment to fit into the display.

One (1) PDF file for illustrations (see attached).

GPO Form 892c (R. 12/17) Proofs.

Contractor to download the "Labeling and Marking Specifications" form (GPO Form 905, R. 7-15) from gpo.gov, fill in appropriate blanks, and attach to shipping containers.

Prior to image processing, the contractor shall perform a basic check (preflight) of the furnished media and publishing files to assure correct output of the required reproduction image. Any errors, media damage, or data corruption that might interfere with proper file image processing must be reported to the contract administrator.

The contractor shall create or change any necessary trapping, set proper screen angles and screen frequency, and define file output selection for the imaging device being utilized. Furnished files must be imaged as necessary to meet the assigned quality level.

Backdrop Banner: wrinkle-free fabric material to match Polydeco Deluxe stretch for feature performance.

Backdrop Display: Adjustable Telescopic Aluminum Light Weight Painted Frame Banner Stand with nylon Padded carrying case.

Retractable Banner: Non-curl Vinyl.

Retractable Banner Display: Premium retractable banner stand with telescoping pole and nylon padded bag.

Table Top Banner: Non-curl Vinyl.

Retractable TOP Display: Premium retractable banner stand with telescoping pole and nylon padded bag.

iPad Brochure Holder/Display wrap material: wrinkle-free fabric material to match Polydeco Deluxe stretch for feature performance.

iPad Brochure Holder/Display: Snap-Tube Aluminum Frame with (1) iPad/Tablet Holder, (2) slots for 8-1/2 x 11" brochures (carries at least 50 brochure each), and (1) Soft Carrying Case.

MARGINS:

Inadequate gripper

PROOFS:

E-MAIL PROOFS (indicate margins): CONTRACTOR MUST NOT PRINT PRIOR TO RECEIVING AN "OK TO PRINT". One set of E-Mailed Electronic Page Proofs. Contractor to submit one "Press Quality" PDF "soft" proof (for content only) using the same Raster Image Processor (RIP) that will be used to produce the final printed product. PDF proof will be evaluated for text flow, image position, and color breaks. Proof will not be used for color match.

E-Mailed proofs (marked with Jacket/Req. Number plus return name and E-Mail address) directly to the Agency at matt.j.gaines@uscis.dhs.gov, and sheena.s.cochran-marzo@uscis.dhs.gov. Contractor must call GPO Contract Compliance Section at (202) 512-0520 immediately upon E-Mailing proofs and immediately upon receiving the returned proofs (or OK E-Mail) back from the Department. Proofs will be withheld not more than (2) workdays from receipt at the Department to receipt in the contractor's plant.

PRIOR TO PRODUCTION SAMPLES (Agency are not going to return the proofs).

Prior to the commencement of production of the contract production quantity, the contractor shall submit one (1) sample of each Item (Banners, and Displays) to: DHS/USCIS/HQ Outreach, 131 M St., NE, 2nd floor, Washington, DC 20529, ATTN: Sheena Cochran-Marzo (202-443-0066). Samples will be tested for conformance of materials and for construction. Each sample must be constructed as specified using the form, materials, equipment, and methods of production, which will be used in producing the final product. All samples shall be manufactured at the facilities in which the contract production quantities are to be manufactured.

Samples will be inspected and tested and must comply with the specifications in all respects. The container

and accompanying documentation shall be marked PREPRODUCTION SAMPLES and shall include the GPO jacket, and purchase order. The samples must be submitted in sufficient time to allow Government testing of the samples and production and shipment in accordance with the shipping schedule.

The Government will approve, conditionally approve, or disapprove the samples within (3) workdays of the receipt thereof. Approval or conditional approval shall not relieve the contractor from complying with the specifications and all other terms and conditions of the contract. A conditional approval shall state any further action required by the contractor. A notice of disapproval shall state the reasons therefor.

If the samples are disapproved by the Government, the Government, at its option, may require the contractor to submit additional samples for inspection and test, in the time and under the terms and conditions specified in the notice of rejection. Such additional samples shall be furnished, and necessary changes made, at no additional cost to the Government and with no extension in the shipping schedule. The Government will require the time specified above to inspect and test any additional samples required.

In the event the additional samples are disapproved by the Government, the contractor shall be deemed to have failed to make delivery within the meaning of the default clause in which event this contract shall be subject to termination for default, provided however, that the failure of the Government to terminate the contract for default in such event shall not relieve the contractor of the responsibility to deliver the contract quantities in accordance with the shipping schedule.

In the event the Government fails to approve, conditionally approve, or disapprove the samples within the time specified, the Contracting Officer shall automatically extend the shipping schedule in accordance with Contract Clause 12, "Notice of Compliance With Schedules," of GPO Contract Terms (GPO Publication 310.2, effective December 1, 1987 (Rev. 01-18)).

Manufacture of the final product prior to approval of the sample submitted is at the contractor's risk. Samples will not be returned to the contractor. All costs, including the costs of all samples shall be included in the contract price for the production quantity.

All samples shall be manufactured at the facilities in which the contract production quantities are to be manufactured.

PACKING:

Pack each Item separately and identify.

Pack suitably per shipping container.

DISTRIBUTION:

Contractor must notify the ordering agency on the same day that the product ships/delivers via e-mail sent to matt.j.gaines@uscis.dhs.gov, and sheena.s.cochran-marzo@uscis.dhs.gov. The subject line of this message shall be Distribution Notice for Jacket 409-109, Req. No. 9-00850. The notice must provide all applicable tracking numbers, shipping method, and Title. Contractor must be able to provide copies of all delivery, mailing, and shipping receipts upon agency request.

Deliver three (3) sets of concept 1, and one (1) set of concept 2 via traceable means to: DHS/USCIS/NVOC, 850 S Street, 2nd floor, Lincoln, NE 68508, ATTN: Jamie Byron (402-484-2014).

All expenses incidental to returning materials, submitting proofs, and furnishing samples must be borne by the contractor.

QUALITY ASSURANCE LEVELS AND STANDARDS: The following levels and standards shall apply to these specifications:

Inspection Levels (from ANSI/ASQC Z1.4):

- (a) Non-destructive Tests -- General Inspection Level I.
- (b) Destructive Tests -- Special Inspection Level S-2.

Specified Standards-- The specified standards for the attributes requiring them shall be:

Prior to award, contractor may be required to provide information related to specific equipment that will be used for production.

PREAWARD SURVEY: In order to determine the responsibility of the prime contractor or any subcontractor, the Government reserves the right to conduct an on-site pre-award survey at the contractor's/subcontractor's facility or to require other evidence of technical, production, managerial, financial, and similar abilities to perform, prior to the award of a contract. As part of the financial determination, the contractor in line for award may be required to provide one or more of the following financial documents:

- 1) Most recent profit and loss statement
- 2) Most recent balance sheet
- 3) Statement of cash flows
- 4) Current official bank statement
- 5) Current lines of credit (with amounts available)
- 6) Letter of commitment from paper supplier(s)
- 7) Letter of commitment from any subcontractor

The documents will be reviewed to validate that adequate financial resources are available to perform the contract requirements. Documents submitted will be kept confidential, and used only for the determination of responsibility by the Government. Failure to provide the requested information in the time specified by the Government may result in the Contracting Officer not having adequate information to reach an affirmative determination of responsibility.
